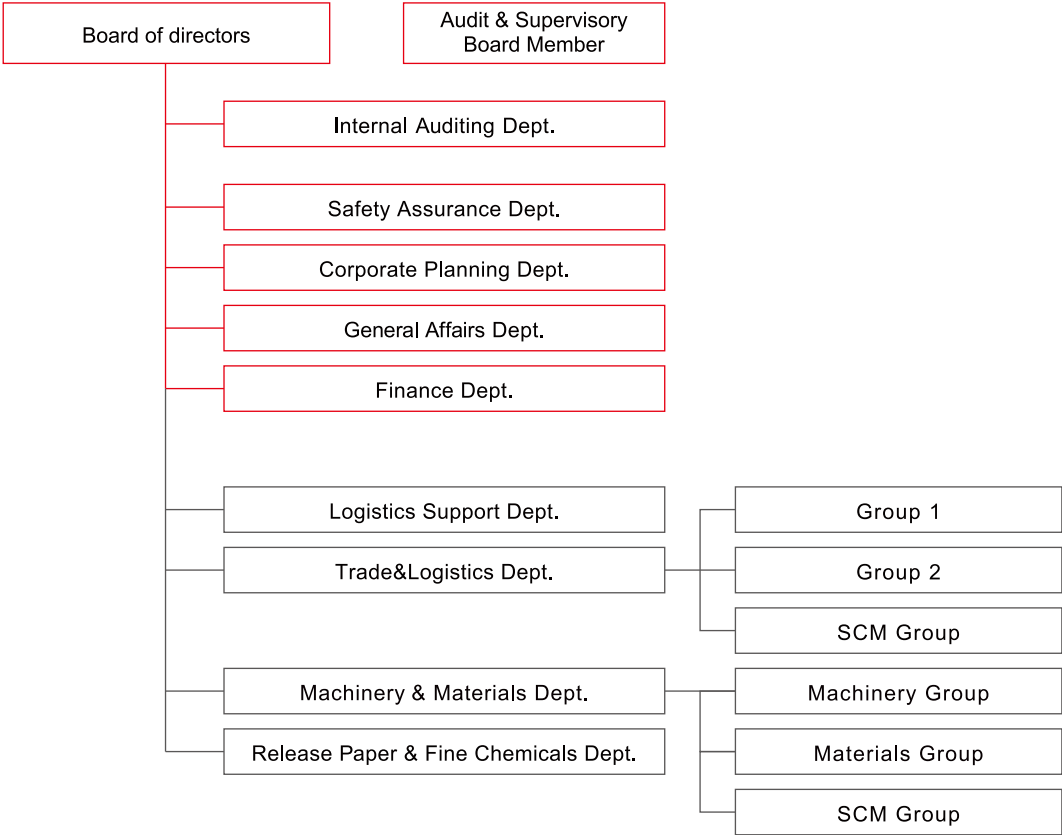

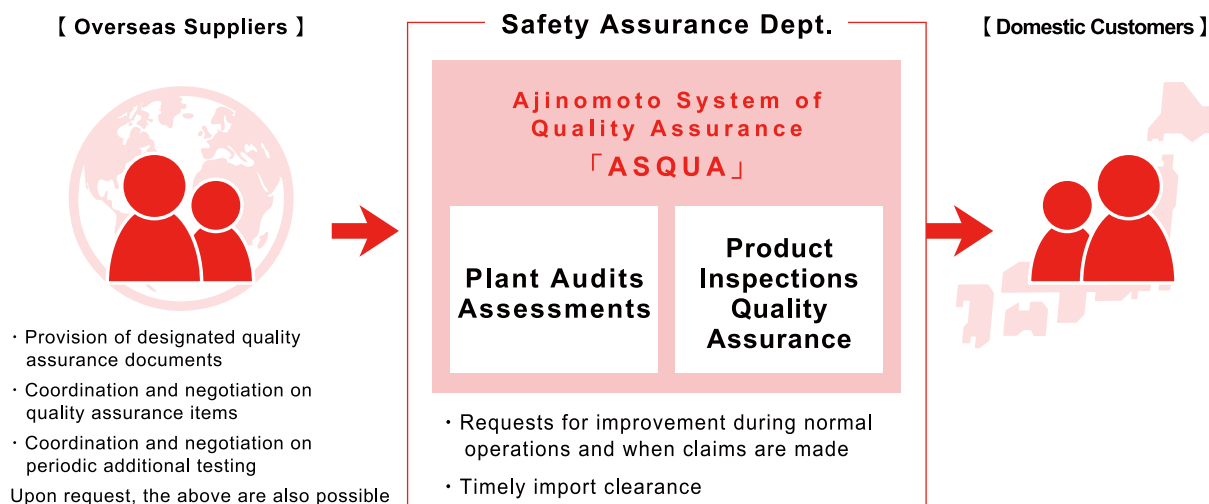
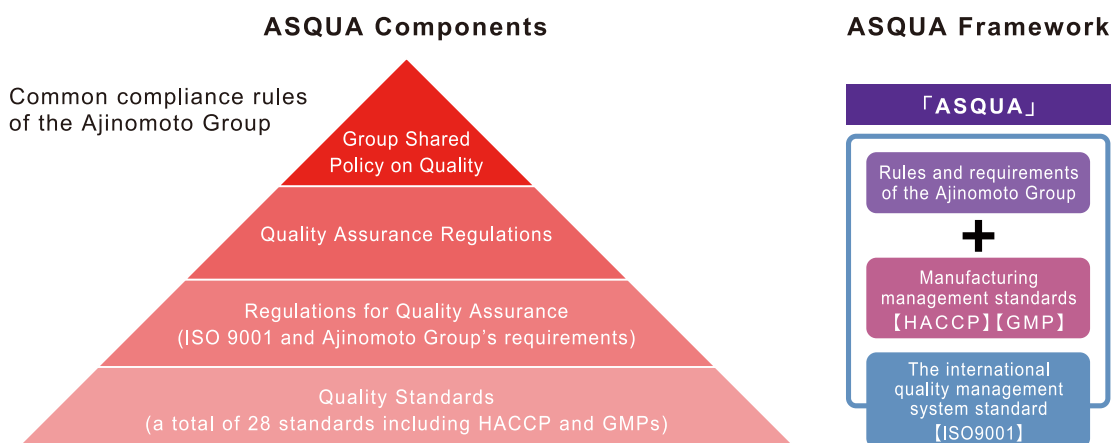
・ Ajinomoto Group Shared Policy on Quality

We contribute to a better life for all throughout the world by providing safe and high-quality products and services.

1. We pay full attention to the requests of our customers, and provide products and services meeting with their satisfaction.
2. We actively provide appropriate information to our customers and continue to improve our trustworthiness.
3. We make no compromises with regard to safety, conducting surveys and research as thoroughly as possible, faithfully complying with applicable laws and regulations, and always delivering products and services of uniform quality.
4. We ensure quality through the Ajinomoto System of Quality Assurance (ASQUA), based on the concepts outlined in international ISO standards.

・ Ajinomoto System of Quality Assurance (ASQUA)

As part of quality assurance, we have implemented and are operating ASQUA, the Ajinomoto Group's original QA system. The foundation of ASQUA consists of such manufacturing management tools as ISO 9001 (the international standard for quality management systems), HACCP (a food safety control approach), and various good manufacturing practices (GMPs) that ensure proper manufacturing. To complement these, ASQUA adds the Ajinomoto Group's own ideas and standards.



■ Quality Assurance

■ Field survey of food ingredients, etc.

To give an example, when we import food ingredients from overseas, we directly audit sanitation and product control at the product plant to determine if it meets set standards and is in compliance with applicable domestic laws and regulations. Subsequently, we present an improvement proposal, if we determine that improvements are needed at a production plant, and conduct confirmations until implementation is complete and perform another audit. To approve start of handling an ingredient internally, we make multiple confirmations in accordance with the Quality Assessment Standard that is fundamental to ASQUA, to ensure that no health consideration is overlooked. Finally, when any problems have been overcome, we get internal agreement to authorize handling of the ingredient. At this point production begins.

【 Provide quality guarantee sheet to customers 】

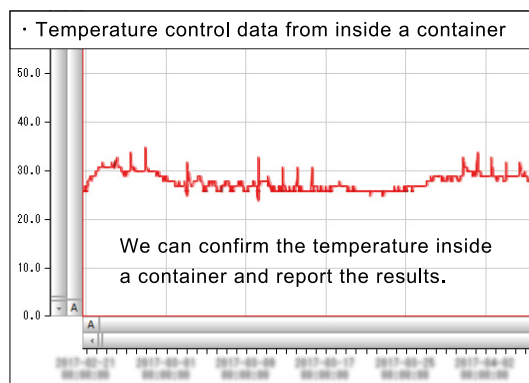
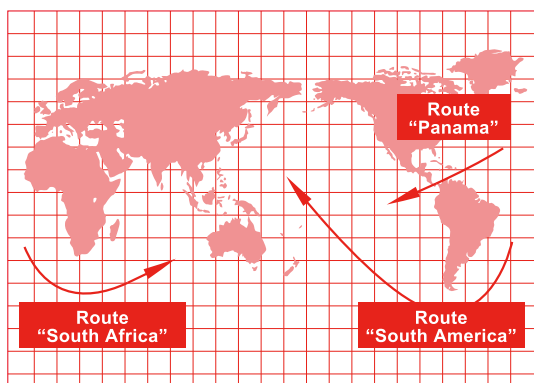
We are able to provide quality assurance certificates to customers for products imported from multiple countries. The content of the quality guarantee sheet that we provide to customers can be customized according to customer requests including coordination with local manufacturers and periodic additional product testing.



【 Transportation method proposals 】

We confirm the route from the local plant to the export port, as well as transshipment sites in the case of maritime transportation, and select appropriate means of transportation.

We pay particular attention to the route, number of days in transit, and other factors relating to cargo that requires temperature control. In cases where records of temperatures inside containers are necessary pursuant to customer requirements, we can install data loggers inside containers and report the results.



■ Proposal of professional trading functions based on AEO

What is the AEO (Authorized Economic Operator) program?

The AEO system is a system whereby trading companies with established cargo security management and compliance regimes are certified by Japan Customs.

Within international logistics, how to guarantee security and smooth out processes has become an international issue from the perspective of strengthening counter-terrorism measures. The World Customs Organization (WCO) has adopted the "AEO Guidelines," a collection of guidelines set forth for customs to certify trade-related businesses that have demonstrated excellent compliance, thereby making the simplification of customs clearance procedures more convenient.

The AEO system was introduced in an effort to strengthen Japan's international competitiveness. Ajinomoto Trading was approved as an "AEO Authorized Exporter" by Tokyo Customs in 2008.



We are able to propose to "AEO Authorized Exporters" a reduction in logistics costs and shortening of lead times through effectively utilizing mitigation and simplification measures in customs clearance based on a trusted in-house system certified by customs. Furthermore, we are able to propose reductions in customs duties within importing countries that fully utilize the economic / free trade partnership agreements (EPA, FTA) between various countries, as such agreements having been topics of discussion in recent times.

Benefits of an AEO Authorized Exporter certification

- An export permit may be granted for cargo held in factories and warehouses outside of customs areas
- Fewer document reviews and cargo inspections when making export declarations



■ Efforts to improve customer satisfaction

Utilizing the ISO 9001 quality management PDCA cycle, we continually carry out improvements and constantly work to improve product quality for customer satisfaction.



■ Food ingredients

■ Comprehensive business package to support food factories.

Both the percentage of food ingredients we source from around the world and the number of consignments we make to overseas factories for food processing are increasing. We are expected to not only pioneer superior materials, but further perform product-specific processing and select optimal raw materials, seasonings, and packaging materials to provide a safe and secure service. When ingredients and products need to be sent from Japan, the know-how concerning export procedures, including legal regulations, food inspections, quality assurance, etc. in each country is also important. Having been an import and export trading company of Ajinomoto products and food ingredients since our foundation, we utilize the Ajinomoto Group network both within Japan and overseas to ensure a safe and reliable service.



■ Export food products

【 Exporting Ajinomoto products 】

We export seasonings, soups, and Chinese-style stir-fry-sauces on consignment from Ajinomoto company, as well as cosmetic and toiletry ingredients and packaging materials, to Ajinomoto Group local companies.



【 Export non-Ajinomoto products 】

We sell Japanese-made food ingredients required in overseas food processing factories via our group company in Thailand. In particular, food ingredients ranging from Japanese-made seasonings (dashi, spices) to frozen products and processed food products have proved essential in local food processing factories. We work together with Thai group companies to actively sell raw food materials to our customers.

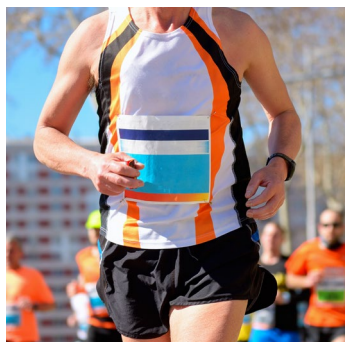

Our products are carefully delivered to ensure even greater product reliability, considering both import and export laws, regulations, and the needs of all our customers.

■ Fish collagen derived from Canadian marine fish

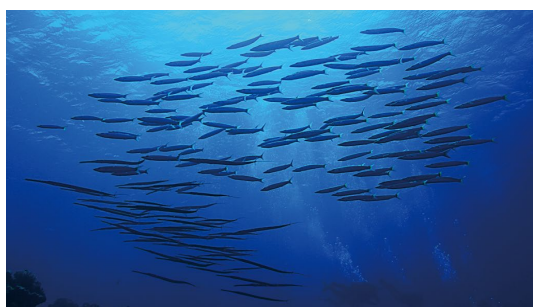
Manufactured from natural marine fish (cod) using their proprietary technology, Kenney & Ross fish collagen is widely used in beauty products, health products, and supplements. Founded in 1945, Kenney & Ross Limited became a wholly owned subsidiary through equity participation with Ajinomoto Group in 2015. Kenney & Ross Limited is one of a small number of companies that produce only natural ocean fish as raw material. Further, their factory is both Halal and Kosher certified.



■ An introduction to fish collagen

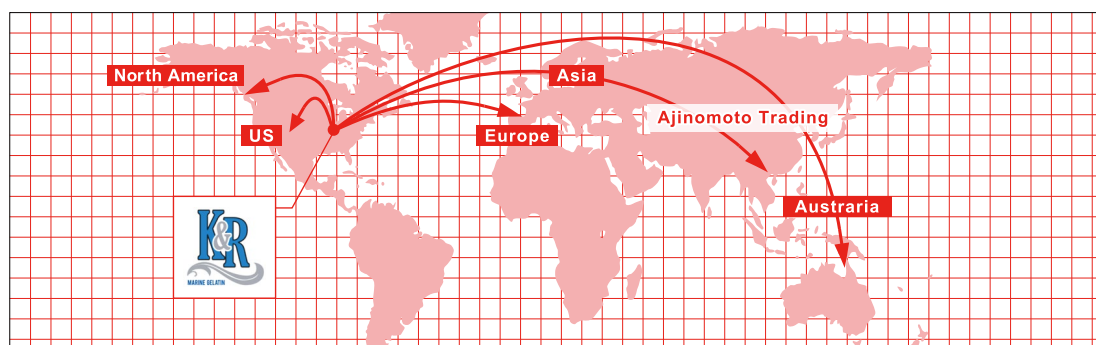
Fish collagen is manufactured from the skin of natural marine fish, such as cod. After the base product fish skin is hydrolyzed and broken down with enzymes, collagen peptides with small molecular weight are turned into a powder by spray drying.

The fish collagen produced by Kenney & Ross Limited has high water solubility, no smell or taste, and can be widely used in dietary supplements, cosmetics, or functional foods.

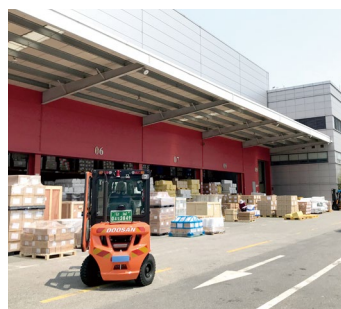

Release paper is a specially processed paper embossed with the look of natural leather or geometric and other patterns. Synthetic leather with a variety of designs can be manufactured by transferring the embossed patterns to the surface of polyurethane or vinyl chloride sheets. This type of synthetic leather is used in a wide variety of everyday products, including fashion items like shoes, bags and clothing, sports shoes with enhanced functionality, and large-sized items, such as furniture and car interiors.

“DN-TP®” is the world’s first non-silicon-type release paper developed by Dai Nippon Printing Co., Ltd. and we have served as general agents for that product. We have been selling to various countries all over the world, including Japan.

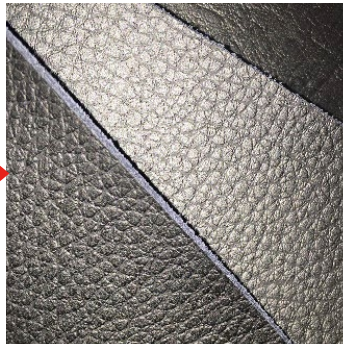

① Sale of release paper



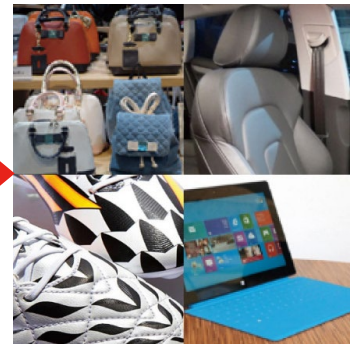
[Synthetic leather manufacturer]

② Synthetic leather manufactured with release paper

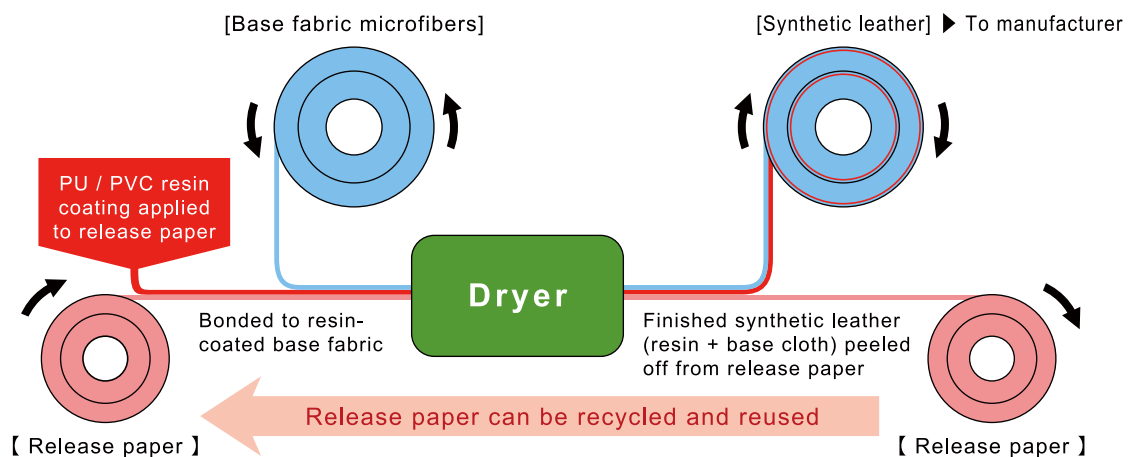

③ Synthetic leather processed onto final product and sold



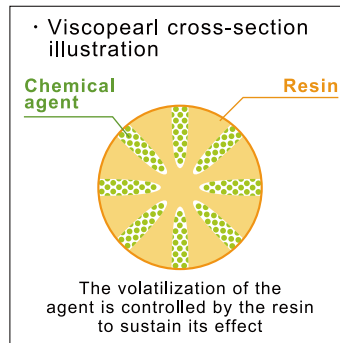
